BACKGROUND

The International Society of Substance Use Prevention and Treatment Professionals (ISSUP) is a global association of practice and research specialists that advocates for substance use prevention, treatment of substance use disorders and recovery; promotes training, competencies building, and professionalization; and forms a global network for the dissemination and implementation of evidence-based practice. The society is being formed by a consortium of international organizations, including the Colombo Plan, the Organization of American States, and the United Nations Office on Drugs and Crime (UNODC), in addition to the Bureau of International Narcotics and Law Enforcement Affairs (INL) of the U.S. Department of State and the local Thai organizing partners of the Princess Mother National Institute on Drug Abuse Treatment (PMNIDAT) and the Office of the Narcotics Control Board (ONCB).

This event will include the official launch of ISSUP and other technical sessions during the first one and half days. During the subsequent days, the Colombo Plan Drug Advisory Programme's (DAP) training arm, International Centre for Certification and Education of Addiction Professionals (ICCE), and the Organization of American States (OAS) Global Master Trainers will be conducting concurrent specialised training workshops on various topics in the field of prevention and treatment. In addition, the International Certified Addiction Professional (ICAP) credentialing examination will also be provided to candidates who have fulfilled the eligibility criteria and received the required continuing education hours on the Universal Treatment Curriculum.

The major goals of ISSUP include the following:

- 1. **Training.** Providing training opportunities and qualifications/credentials, supporting the professional development of professionals working in drug demand reduction.
- 2. **Research.** Sharing research and promoting the need to put research into practice.

- 3. **Professionalization.** Recognizing study and practice within the substance use field as a profession and advocating for universities to incorporate this discipline into their academic programmes.
- 4. **Networking.** Developing the community of substance use treatment and prevention professionals and facilitating their communication and collaboration.

ICAP AND RC EXAMINATIONS

For those who are taking the International Certified Addiction Professional (ICAP) and Recovery Coach (RC) examinations, a pencil-and-paper examination will be administered on **July 11, 2015**. ICAP Level I may be taken in English, Dari, Pashto, and Bahasa Indonesia. Examinations for ICAP Levels II, III and RC will only be in English.

On the examination day, candidates must bring the following to the testing center:

- Valid identification documents that contain the applicant's signature and picture (i.e. passport, driver's license and National Identity Card). Please note that expired identification documents, work ID card, credit card and student IDs will not be considered.
- A photocopy of the above valid identification documents with photo.
- Printed copy of the telegraphic transfer/ receipt of examination fee.
- Letter of Acceptance from ICCE
- Pencil (shade 2B)

Candidates are not allowed to use aids, books, or references of any kind. Prohibited materials include:

- Calculators, as these will not be needed for the examinations;
- Dictionaries and language dictionaries for translation:
- Mobile phones and earpieces;
- iPods, MP3 players, and other portable players and devices;
- Cameras including camera phones; and,
- Pagers, messaging devices, and PDAs.
- Food and beverages, except for bottled water, will not be allowed in the testing room.
