#### **Executive Summary**

Psychoactive substance use and substance use disorders (SUDs) remains remain to be a major problem around the world. Which is negatively effect on global health and social and economic functioning. Though people who suffer from SUDs must received treatment, the number of who actually get treatment is very low as well as non-quality of the treatment they receive is another crucial problem. Therefore enhancing of the quality of treatment is very important. One of the best solution to the above problem is to develop treatment staff's capacity by providing training to evidence-based practices.

Preventive Education and Training Unit of the National Dangerous Drugs Control Board (NDDCB) organized and conducted training on psychology and pharmacology (UTC - 01) for 24 officers of the NDDCB which was held on  $23^{rd}$ ,  $24^{th}$  and  $25^{th}$  of August 2022 at NDDCB Auditorium.

In selecting officers for the workshop, criteria were considered, such as having worked in the field of drug prevention and treatment for more than two years, or at least a basic degree. Two weeks before the training, they were given initial notice and a WhatssApp team was formed to provide them with the information they needed to prepare. The organizing team had also made arrangements to provide accommodation for officers working outside Colombo. Food, refreshments and other basic necessities were also provided to each trainee.

Training was provided by UTC certified trainers and the curriculum was provided free of charge by the Colombo Plan Secretariat and the initial cost was borne by the US State Department.

Post-test of the training showed that the trainees had made significant progress in their knowledge, skills and attitudes through the training. Pre-assessment tests and post-evaluation tests were used for this and each test was performed very reliably online.



## INTRODUCTION

- -Periodic reviews to enhance retention; and Learning assessment exercises.




### POST- TEST
